

Logansport Savings Bank Giveaway Contest Rules

Giveaways from Logansport Savings Bank Rules – No purchase is necessary to win. Applicant will be entered for a chance to win after they sign up online or fill out a form/ticket. Must be 18 years of age or older to enter. One entry per person.

1. Eligibility: Contest is open only to those who sign up in person or on Logansport Savings Bank's website. The contest is only open to legal residents of The United States of America and is void where prohibited by law. Winners may be required to show proof of identification. Employees of Logansport Savings Bank (the "Sponsor") their respective affiliates, board of directors, subsidiaries, and their immediate family members (immediate family members include spouse, parents, step parents, children, step children, siblings, step siblings and their respective spouses) and/or those living in the same household of each are not eligible to participate in the contest.

4. How to Enter: The Contest must be entered by submitting an entry in person or using the online form provided on Logansport Savings Bank's website. The entry must fulfill all contest requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Logansport Savings Bank. You may enter **only once**, and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Logansport Savings Bank.
